AN ACT to amend the Legal Profession Act No. 25 of 2011.

[14th September, 2012].

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and House of Representatives and by the authority of the same as follows—

1. This Act may be cited as the

LEGAL PROFESSION (AMENDMENT)
ACT, 2012

and shall be read as one with the Legal Profession Act No. 25 of 2011, hereinafter referred to as the principal Act.

2. Section 3 of the principal Act is repealed and the following section is substituted—

“The Bar Association

3. The Grenada Bar Association is hereby recognised as the representative body of the Legal Profession.”

3. Section 5 of the principal Act is amended—

- (a) in subsection (2), by deleting paragraph (c); and relettering the subsequent paragraphs accordingly; and
- (b) by repealing subsection (3) and substituting the following subsection—

“3. The persons nominated by the Grenada Bar Association under subsection 2(d), shall consist of the following—

- (a) one member from the Inner Bar; and
- (b) two members of the Utter Bar, one of whom has no more than ten years standing in the practice of law in Grenada.”

4. Section 6 of the principal Act is amended by repealing the words “section 5(2)(c), (d) or (e)” and substituting the words “sections 5(2)(c) or (d).”

“(3) The Chairperson shall preside at all meetings of the Council at which he or she is present, and in the case of the absence of the Chairperson from any meeting, the Attorney General or the Solicitor General in the Attorney General's absence shall preside at the meeting, and when so presiding, shall have an original and a casting vote.”

8. Section 24 of the principal Act is amended—
